



STEVENAGE FOOTBALL CLUB 2022/23 SEASON TICKET TERMS & CONDITIONS

The following terms and conditions outlines the Club's commitment to the individual purchasing a 2022/23 Stevenage Football Club Limited Season Ticket:

AGE CLASSIFICATION

The age of applicants on 1st August 2022 will determine discount qualification for season ticket(s), categories are defined as follows.

Adult – Born on or between 01/08/63 – 01/08/2004 (18-59).

Concessions – Disabled (Proof of medium-high living disability allowance or equivalent PIP Award), Students with valid ID Card, 60 & over – Born on or before 31/07/1963, Ex/Current Serviceman/woman (with a Defence Discount Service Card), NHS/Emergency Service Workers.

Under 18 – Born on or after 02/08/2004.

Under 12 – Born on or after 02/08/2010.

Concessions have a duty to inform the Club if circumstances change, and upgrade remaining tickets. Proof of qualification for Concessions must be carried at all times. Failure to provide proof may result in sanctions being imposed which may include, but not limited to, ejection and the cancellation of your Season Ticket without refund.

The Club reserve the right to request each Season Ticket holder provides proof of identification in the form of a Driving License, Passport or valid Photo ID Card upon entry or at any time within the Stadium footprint.

REFER A FRIEND

A referral is validated when the 'Friend' purchases a 2022/23 Season Ticket and references the original buyer's www.borotickets.co.uk Reference Code.

The original buyer must have been a 2021/22 Season Ticket holder. The 'Friend' must be a brand-new Season Ticket holder or not held a Stevenage FC Season Ticket in either 2020/21 or 2021/22.

The discount will not be made at point of purchase (unless bought in the Stevenage FC Club Shop). Once referral has been validated, both the original buyer and 'Friend' will receive a 10% refund on the cost of their Season Ticket. Multiple references may be made, up to the value of 100% of your 2022/23 Season Ticket.

FIXTURES

Season Tickets provide admission to 23 First Team home league matches in EFL League Two. Season Tickets are not valid for away matches, cup matches or play-off matches, but will provide you with ticket priority for any aforementioned fixtures. Season Ticket Holders shall have priority over Non-Season Ticket Holders.

The Club reserve the right to amend the date, time and venue of any publicised fixture for any reason without prior notification or reimbursement of any such costs. Additionally, the Club shall not be responsible for the reimbursement of any additional costs supporters incur including but not limited to travel, accommodation or employment leave etc.

LIMITED CAPACITY

If capacity is limited for any reason, the Club will run a ballot process in advance of the relevant fixture(s). Season Ticket Holders shall be required to register their interest to attend the specific fixture(s) and a random computer generator shall be used to select attendees. If a Season Ticket Holder is unsuccessful in the ballot, then they shall be treated under the terms of the Behind Closed Door Fixtures criteria contained in these terms and conditions. Further information regarding the ballot process will be communicated to Season Ticket Holders in advance of the first ballot of the season.

BEHIND CLOSED DOORS FIXTURES

If the Club is instructed by any relevant party to play a qualifying Season Ticket fixture behind closed doors, each individual Season Ticket Holder shall be entitled to receive a pro-rata refund on their Season Ticket.

The Club will in the first instance provide Season Ticket Holders with the option to receive a pro-rata Club Credit (redeemable against tickets and merchandise) which may be accepted or declined for a refund.

FIXTURE POSTPONEMENTS

In the event that a qualifying fixture is postponed or abandoned you shall automatically be entitled to attend the re-arranged fixture. No refunds will be provided in the event that you are unable to attend the re-arranged fixture.

CANCELLATIONS

In the event that a qualifying fixture is cancel by EFL and removed from the league's official fixture list, Season Ticket Holders shall be entitled to receive a pro-rata refund. The Club will in the first instance provide Season Ticket Holders with the option to receive a pro-rata Club Credit (redeemable against tickets and merchandise) which may be accepted or declined for a refund payable by 31st May 2023.

PAYMENT PLAN

The Payment Plan option is only available online and the Club reserve the right to incur a £20.00 administration fee, payable upon collection of your Access Card. Should a payment fail for any reason your Season Ticket will be suspended for a period of 3 workings days. Should payment not be received during this time period your Season Ticket will be cancelled. Should your payment fail on 3 occasions your Season Ticket will be cancelled immediately and will not be reactivated.

No refunds will be provided for payments already received for Season Tickets cancelled due to failed payments. Payment instalments will be taken on the same monthly date as the initial date of payment.

SEAT ALLOCATION

Season Ticket Holder seats are allocated at the time of purchase and are non-transferable. The Club reserves the right to relocate Season Ticket Holder seats to another equivalent area of the stadium, for any such fixture as it requires. Where possible seats will be reallocated in purchase groups.

Pricing & Additional Charges

Prices displayed include VAT at 20% and are subject to change at the Club's discretion.

Replacement Season Ticket Access Cards shall be replaced at a replacement fee of £10.00.

ACCEPTANCE OF TERMS

By purchasing a Season Ticket, you are indicating that you have read, understood, accepted and agreed to abide by the Ground Rules and Regulations, as well as The Lamex Stadium Supporter COVID Code of Conduct. Additionally, if you are buying on behalf of someone else your purchase will include their acceptance to the aforementioned regulations.

In line with the Club's COVID Code of Conduct by attending fixtures you acknowledge that you do not have any symptoms of, have tested positive for, or are isolating/self-isolating from COVID-19 or any such variants.

In the event that a Season Ticket Holder sustains a ban from the stadium for breaching ground regulations or the Supporter COVID Code of Conduct, no refund will be given.

All Season Tickets are sold to the named individual on the Season Ticket Access Card and are non-transferable. Any such refunds or credits will be issued to the lead booker, and it shall be their responsibility to distribute such reimbursements.

REMITTANCE

Season Tickets can be purchased online from www.borotickets.co.uk, or from the Stevenage FC Club Shop. Should you require assistance, please call the Ticket Office on 01438 223223. 2022/23 Season Ticket Access Cards will be available ahead of the first home league game of the 2022/23 season.
